

Privacy Policy, Terms & Conditions



- 1) The Kashmir-SNP Archives herein after also referred as ' SNP Archives / Archive is a private collection of documentary heritage of Kashmiri Pandit culture and other materials.
- 2) Prerogative to use the Archive is limited and restricted. Access to use the resources are at the sole discretion of the Archive.
- 3) The ' Archive' may, within its means make available its resources, subject to the availability of the material/s in the collection within its possession, sought by the user and in compliance to the terms and conditions.
- 4) The user in this regard shall make a written request addressed to the Curator Archivist in respect of the specific resource sought from the Archive.
- 5) The use of the materials possessed by the Archive and provided by it to the user shall only be for the exclusive use of academic and research work.
- 6) No materials in the possession of the Archive are loanable or issuable.
- 7) No photocopying and photography/Screenshots of any materials of the Archive is permitted except in the case for use of images subject to the permission granted by the Curator Archivist.
- 8) Bona-fide use of materials in the collection is permitted in the manner, form and place as may be determined by the Archive.



9) Any user desirous to seek a resource from the Archive for bona-fide use of research and academic pursuits must make the specific request in writing to the Curator Archivist. No pre-survey or inspection of resource is allowed. All requests for materials sought must be specific and explicit. No general queries will be entertained.

10) Any material used by the user shall be returned to the Archive in its original form. Any damage or mutilation caused to the material resource as a result of its wrongful use by the user shall be chargeable to the user to the extent determined by the Archive. The decision of the Curator Archivist in this regard shall be final and binding on the user.

11) The information and data obtained from the Archive by the user is at the own risk of the user. The Archive will not be responsible or liable for any loss or damages suffered by the user as a result of the use of the materials of the Archive.

12) The Archive respects the Intellectual Copyrights of others and expects its adherence by all the users of its resource with regard to the materials in the collection. Any violation, infringement or act of plagiarism is strictly prohibited. Any violation in this regard for damages and other legal consequences shall be at the sole risk of the user. Replication of any material in the possession of the archive is not permitted.

13) The above stated privacy policy, terms and conditions are indicative and will keep on evolving. Any addition amendments and changes in these terms and conditions shall apply in future course as determined by the Archive from time to time and shall be binding on all the users at all times.

14) Access to use the resource of the Archive is a restricted courtesy and not a matter of any right. All authorization in this regard is reserved with the Archive.

15) Any user who may be desirous to use the resource of the Archive shall always pre-inform the Curator Archivist (Archive) for the materials/s sought and there after the use of Archive record the confirmation of service/s used and material/s utilized.
